WHEREAS, the Township advertised and invited bids for the grant of a contract for the collection and disposal residential municipal waste beginning January 1, 2023 and ending December 31, 2024, with an option to extend the contract for up to two additional years under certain conditions; and

WHEREAS, the Township awarded the contract to Penn Waste, Inc. by Resolution No. 7-2022, dated September 1, 2022; and

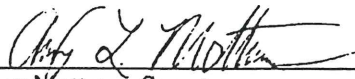
WHEREAS, the Township exercised its first renewal option by Resolution No. 11-2024, dated September 5, 2025; and

WHEREAS, the Township has decided to exercise its second option, as set forth in Section 2.04 of the Bid Specifications, to renew Penn Waste, Inc.'s contract for calendar year 2026 at the prices and on the terms set forth in Penn Waste, Inc.'s bid and contract.

NOW, THEREFORE, BE IT RESOLVED that Penn Waste, Inc.'s originally awarded contract for the collection of residential municipal waste under the terms and conditions of the bid documents, as defined in the Specifications and Instructions to Bidders for Residential Municipal Waste Collection Contract, is hereby renewed for the period of January 1, 2026 to December 31, 2026.

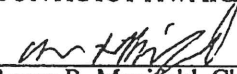
General Conditions:

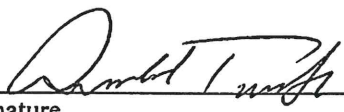
